Partial/Full Scholarship Application
Terms and Conditions

By submitting a digital application, through the JYSA website, I certify that the information provided is correct. I have read the scholarship guidelines. I understand that my request may be denied. I understand that my scholarship will expire within 60 days. I understand that I must reapply for a scholarship each year. I certify that the information submitted is true and correct to the best of my knowledge.

I also understand that if I do not use the scholarship I have been awarded, I will provide at least a notice to cancel the scholarship. Failure to do so will result in losing remaining scholarships allocation and the participant will not be eligible for any additional scholarships to JYSA programs for two (2) full years.

I. PURPOSE

The purpose of the application is to provide guidelines for the application and distribution of scholarships for Justin Youth Sports Association ("JYSA") programs and events.

II. POLICY

The scholarship policy establishes the eligibility requirements, distribution, award level, and guidelines that apply to all JYSA programs for which a fee is charged. The Scholarship Program will serve children and youth. It is the desire of JYSA that scholarships exist to execute the mission of JYSA by assisting low-income families and subsidizing costs associated with JYSA programs and events, in accordance of guidelines set forth by 501©(3) Youth Organizations, to the best of its ability.

III. ELIGIBILITY

- Applicants are required to be JYSA athletes for the most recent upcoming sport/season/registration.
- Applicants are required to provide all required information on the online application form in order to be considered.

IV. APPLICATION

Complete the Scholarship Application Form online, one form per eligible athlete. Applications must be completed by a parent or guardian if the recipient is under the age of 18.

Scholarship eligibility does not guarantee an admittance or available space for all programs and events as funding is determined by budget allocations each fiscal year.

JYSA Executive Board staff will review applications. Applicants will be notified by email of their status after the application has been processed. Applicants will be notified if a scholarship has been granted.

V. DISTRIBUTION

Partial scholarships will be awarded upon availability. Funding is determined by budget allocations each fiscal year.

Each partial scholarship covers a percentage of the program or event registration fee. The scholarship does not cover late fees, additional supply fees, or add-on fees.

Recipients of scholarships have five (5) business day from notice of award to cancel or decline the scholarship. Failure to provide the above-stated notice will result in the recipient losing any remaining scholarship allocations and the participant will be ineligible for any additional scholarships for two (2) full years from the date of the non-compliance.

VII. MAXIMUM ELIGIBILITY

Each eligible family athlete is limited to a maximum of \$180 in scholarships per year. Some scholarships for specific programs may differ depending on awarded grants. Scholarships can be used for only upcoming/current programs or events.

Scholarship funding is available on a first come, first serve basis.

Scholarship recipients who provide false or incomplete eligibility information to JYSA will immediately forfeit their scholarship. Household accounts that have a past due balance for any JYSA program will not be eligible for a scholarship until the balance has been paid in full.
